As former owners of Katolight Corporation (now Rolls-Royce Solutions America), Lyle and Kay Jacobson were longtime supporters of United Way. Their history includes conducting successful employee campaigns, giving personally, giving through their business and giving through their donor advised fund of the Mankato Area Foundation. In addition to supporting United Way, Lyle and Kay gave additional support to many of the United Way agencies. Their philanthropic areas of emphasis were youth activities, education, the arts and humanitarian organizations. Overall they had a keen interest in enhancing the quality of life in the Mankato area helping to make it an attractive community for employee retention and recruitment and helping make it a community that provides opportunities for healthy family lives. 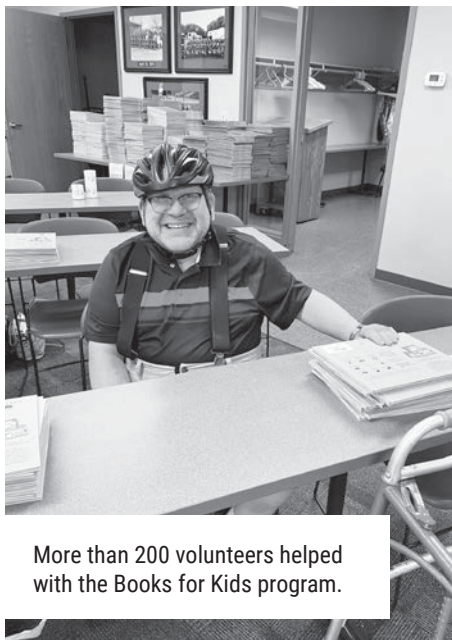

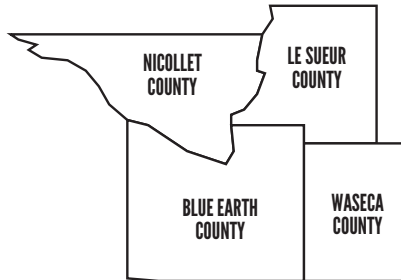
